# MEMBERSHIP CARD RULES

**ARTICLE 1** : This card is obligatory for persons 18 years old and over, professionals from Antiquity-Flea Market. The members are engaged to prove their quality as professionals (VAT, Business Register).

**ARTICLE 2** : The signature of the membership's request lead to an obligation on the part of the exhibitor or buyer to comply with the requirements of these rules. The exhibitors or buyers are engaged to apply all the articles without reservation of any kind .

**ARTICLE 3** : Any transgression risks sanctions which could include immediate and permanent exclusion from fairs and flea markets. The organisers reserve the right to accept or refuse any applications for membership without having to justify their decision.

**ARTICLE 4** : The membership card gives access to the International Dealer Fairs of Chartres and Lille as a professional buyer or exhibitor. It also gives access to our Antiquities-Flea Markets which are **EXCLUSIVELY PROFESSIONAL**.

The card must be shown at each Fairs and Flea Markets.

**ARTICLE 5** : The membership card is obligatory and personal to each applicant. An ID photograph must be displayed on each card. Each card will have an individual ID number.

**ARTICLE 6** : Any loan or passing on the membership card is forbidden under sanction of immediate exclusion from all sales.

**ARTICLE 7** : **A supplementary card will be required for married or civil partners with the same family name. Persons accompanying family businesses and loaders will also require a supplementary card.**

**A reduced rate as 10€ is applied per person and per card, limited to 3 supplementary cards.**

**ARTICLE 8** : The member remains responsible for any loss, theft or deterioration of the card. No replacement card will be issued and a new membership application to 25€ will need to be submitted.

**ARTICLE 9** : No membership card request will be accepted without payment of the full fee and proof of professional status of **less than 3 months**, one ID photo must be supplied, a stamped self addressed envelope ( 1 card = 1 stamp, 2 or 3 cards = 2 stamps, etc).

For foreign, must add 2€ for mailing costs.

To avoid mailing costs, you will be able to get your card at the members' office during the fairs.

**ARTICLE 10** : You have a **maximum of 15 days**, from the date of receiving your file, to provide any missing documents, otherwise your request will be canceled without any refunded.

**ARTICLE 11** : An invoice will be supplied to facilitate your repayment of VAT.
