# **REGULATIONS FOR AN ANNUAL STAND** **BOOKING AT CHARTREXPO**

- ARTICLE 1** An exhibitor's signature on the booking application form constitutes an undertaking to comply these regulations. Exhibitors agree to make no claim against the organisers if the event should be cancelled. Exhibitors undertake to apply all these articles without reservation.
- ARTICLE 2** Any failure to comply will incur a penalty and may lead to immediate exclusion from the event and any subsequent event. The organisers reserve the right to accept or refuse any application without having to justify their decision. Allocation of stands is the sole responsibility of the organisers.
- ARTICLE 3** Exhibitors must provide documentary evidence of their trade status (VAT/Business reg.)  
RENEWABLE EVERY THREE MONTHS.
- ARTICLE 4** NO STAND TO BE SUB-LET; ANY BREACH WILL RESULT IN FEES BEING FORFEIT. (Except in case of illness or vehicle breakdown, certified by a specialist and **in the name of the interested**)
- ARTICLE 5** The organiser reserve the right, in unforeseen circumstances, to alter the opening date or the duration of the event. In such case, exhibitors may not claim any indemnity or refund.
- ARTICLE 6** Each exhibitor is legally responsible for his/her stand. The exhibitor must take every precaution against THEFT, STORM, LEAKS AND WATER DAMAGE, LOSS, BREAKAGES,... and must be properly insured against such.
- ARTICLE 7** In case of withdrawal, the exhibitors have to prevent of their absence by letter or by e-mail, 3 days (72 hours) before the event. For any unjustified and late absence, the exhibitor will have to settle his stand in the whole lot, except case of absolute necessity certified by a specialist, 50% of the stand will be cashed (illness or vehicle breakdown). The already paid sums will remain acquired by the organisers.
- ARTICLE 8** A security guard will operate overnight, but no responsibility will be assumed by the organisers.
- ARTICLE 9** There shall be no touting of goods to the public and no distribution of leaflets, fliers or other advertising material without prior agreement by the organisers.
- ARTICLE 10** **Chartres** : Vehicules may be brought on site on the day preceding the event from 4 pm to 7 pm (unless event occupying Chartrexp) and on the morning of the event from 5.30 am to 7.45 am  
Trade entry at 8.00 am sharp.  
**Lille** : Vehicules may be brought on site on the morning of the event from 6 am to 8 am.  
Trade entry at 8.15 am sharp.  
**It's forbidden for all exhibiting vehicles inside and inside to leave the exhibition center before 11.30 am.**
- ARTICLE 11** No application or booking can be considered unless accompanied by a cheque for the full cost of the stand ( to be cashed after the event).
- ARTICLE 12** Membership card is obligatory. Every person, buyer or seller, not possessing membership card can come neither to buy or to sell on our International dealer fair (Chartres and Lille) as well as on our Antiquities-Brocantes.
